RESOLUTION NO. 96-80

A RESOLUTION REQUESTING THE HEAD, TAX MAPPING DIVISION,  
ENGR. DARLITO A. PAREJA, TO PREPARE A SKETCH PLAN/MAP  
OF THE PARCELS OF LAND AFFECTED IN CIVIL CASE NO. 711-  
0, ENTITLED, "THE CITY OF ORMOC, VERSUS, PATRICIO  
OCUBILLO, ET AL.", FOR EMINENT DOMAIN, INDICATING  
THEREIN THE AREA ALREADY UTILIZED BY THE CITY  
GOVERNMENT OF ORMOC AND OTHER OFFICES, AS WELL AS THE  
AREA ALREADY DONATED TO OTHER OFFICES AND THOSE  
EARMARKED FOR OTHER PURPOSES, AND THE AREA PRESENTLY  
OCCUPIED BY PRIVATE INDIVIDUALS WITH NAMES OF THE  
OCCUPANTS.

WHEREAS, Civil Case No. 711-0, entitled, "The City of Ormoc,  
versus, Patricio Ocubillo, et al." for Eminent Domain, has been resolved  
by the then Court of First Instance in Ormoc City, in favor of the City  
of Ormoc;

WHEREAS, the decision in the aforecited case has been affirmed with  
modifications by the Court of Appeals;

WHEREAS, some owners of the parcels of land affected in said case  
have filed requests for the release of their lands, or portion thereof,  
alleging that the same are not affected by the Government Center Site or  
no longer needed by the City Government;

WHEREAS, for the proper determination of the actual and future use  
of the parcels of land expropriated by the City Government of Ormoc, in  
Civil Case No. 711-0, it is necessary that a sketch plan/map of the lots  
affected thereby be prepared;

WHEREFORE, on motion of Kagawad Mariano Y. Corro, Chairman, Committee on Public Properties, duly seconded by Kagawad Benjamin B. Lladoc; be it

RESOLVED, to pass a resolution REQUESTING THE HEAD, TAX MAPPING DIVISION, ENGR. DARLITO A. 
