A RESOLVION REQUESTING THE CITY LEGAL OFFICERS, IN CLETO L. EVANGELISTA, JR., TO TAKE IMMEDIATE STEPS IN THE REGISTRATION OF THE EMINENT DOMAIN CASE RESOLVED IN A OR, OF THE CITY OF ORMOC IN CIVIL CASE NO. 711-0, ENTITIED, "THE CITY OF ORMOC, VERSUS, PATRICIO AL." FOR EMINENT DOMAIN, CERTIFICATES OF TITLE OF THE PARCELS OF LAND AFFECTED THEREBY.

EREAS, the then Court of First Instance in Ormoc City, in Civil Case No. 711-0, entitled, "The City of Ormoc, versus, Patricio Ocubillo, et al." for Eminent Domain, rendered a decision confirming the right of the City of Ormoc to expropriate the parcels of land described therein;

WHEREAS, the Court of Appeals, in CA G.R. No. 50652-R affirmed with modifications as to the fair, reasonable and just market value of some of the lots involved in the aforecited case;

WHEREAS, the aforecited Decisions of the Court of First Instance and the Court of Appeals were not annotated in some of the Certificates of Title of the parcels of land affected thereby, which omission may prejudice the interest of the City Government of Ormoc;

WHEREFORE, on motion of Kagawad Mariano Y. Corro, Chairman, Committee on Public Properties, severally seconded by mga Kagawad Alfredo F. Capahi, Benjamin B. Lladoc & Sotero M. Pepito; be it
