RESOLUTION VO. 3 S. 1996 ENTITLED, "A RESOLUTION APPROVING THE REALIGNMENT OF THE LOT ACQUISITION OF A RESETTLEMENT SITE IN THE AMOUNT OF FOUR MILLION PESOS 000,000.00) TO ROAD-RIGHT-OF-WAY OF THE SAME AMOUNT AND EQUESTING THE HONORABLE SANGGUNIANG PANLUNGSOD NG ORMOC FOR APPROVAL OF THE SAME".

WHEREAS, this august Body is in receipt of the City Development Council (CDC) Resolution No. 3 s. 1996 entitled, "A RESOLUTION APPROVING THE REALIGNMENT OF THE LOT ACQUISITION OF A RESETTLEMENT SITE IN THE AMOUNT OF FOUR MILLION PESOS (#4,000,000,00) TO ROAD-RIGHT-OF-WAY OF THE SAME AMOUNT AND REQUESTING THE HONORABLE SANGGUNIANG PANLUNGSOD NG ORMOC FOR APPROVAL OF THE SAME":
