RESOLUTION NO. 96-85

A RESOLUTION APPROVING ORDINANCE NO. 96-001 OF THE
SANGGUNIANG BARANGAY OF BARANGAY GREEN VALLEY, THIS
CITY, ENTITLED, "AN ORDINANCE PROHIBITING RESIDENTS OF
THIS BARANGAY FROM ITS INDISCRIMINATE DUMPING OF
GARBAGES, AND/OR UNSANITARY DISPOSAL OF ANY DOMESTIC
WASTE MATERIALS, PROVIDING PENALTIES IN VIOLATION
THEREOF."

WHEREAS, this august Body is in receipt of Ordinance No. 96-001 of
the Barangay Council of Green Valley, this city, entitled, "AN ORDINANCE
PROHIBITING RESIDENTS OF THIS BARANGAY FROM ITS INDISCRIMINATE DUMPING
OF GARBAGES, AND/OR UNSANITARY DISPOSAL OF ANY DOMESTIC WASTE MATERIALS,
PROVIDING PENALTIES IN VIOLATION THEREOF";

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the
aforecited Ordinance at issue (and all other ordinances of the barangays
in Ormoc City) is, by law mandated to Review on whether the said
