RESOLUTION NO. 96-89

A RESOLUTION AUTHORIZING THE CITY TREASURER TO CHARGE PAYMENT OF UNCLAIMED INCENTIVE ALLOWANCE IN THE AMOUNT OF ONE THOUSAND THREE HUNDRED FIFTY PESOS (P1,350.00) FOR DECEMBER 1995 TO ATTY. ARTURO P. SUAREZ, REGISTER OF DEEDS, THIS CITY, AGAINST THE ACCOUNT- PROVISION FOR PRIOR YEAR'S OBLIGATION OF THE ANNUAL BUDGET CY 1996.

WHEREAS, this august Body is in receipt of 1st Indorsement dated 21 May 1996 from the Office of the City Mayor requesting that the allowance of Atty. Arturo P. Suarez, Register of Deeds, this city, which he failed to receive, be charged against the appropriation intended for said purpose for fiscal year 1996;

WHEREAS, the City Accountant, through 5th Indorsement dated 28 May 1996, has stated that the claim of Atty. Arturo P. Suarez, Register of Deeds, this city, of his unpaid allowance for the month of December 1995 be charged to the Account- Provision- Prior Year's Obligations of the Annual Budget CY 1996, since said claim was not submitted to the said Office as of December 31, 1995 and therefore not included in the Certified List of Account Payables as of December 31, 1995;

WHEREAS, the City Budget Officer, through 6th Indorsement dated 11 June 1996, has recommended to charge the said claim of Atty. Arturo P. Suarez, Register of Deeds, this city to current appropriation- Provision for Prior Year's Obligation in the amount of ONE THOUSAND THREE HUNDRED FIFTY PESOS (P1,350.00);

WHEREAS, the OIC-City Treasurer, through 8th Indorsement dated 14 June 1996, has stated that funds are available for the purpose, subject however, to accounting and auditing rules and regulations;

NOW, THEREFORE, on motion of Kagawad Alfredo F. Capahi, Chairman, Committee on Finance, duly seconded by Kagawad Benjamin B. Lladoc; be it




