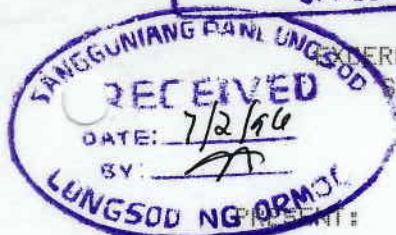

RESOLUTION NO. 96-91

A RESOLUTION AUTHORIZING THE CITY ACCOUNTANT TO CHARGE PAYMENT IN THE AMOUNT OF TWO THOUSAND SEVENTY PESOS (P2,070.00) INCURRED BY THE OFFICE OF THE REGISTER OF DEEDS, THIS CITY, FOR ITS PAYMENT TO ROGINAS NEWS MAGAZINE STORE CHARGEABLE AGAINST THE ACCOUNT-PROVISIONS FOR THE PRIOR YEAR'S OBLIGATIONS- A CURRENT APPROPRIATION.

WHEREAS, this august Body is in receipt of a letter dated 30 April 1996 from the Office of the City Mayor requesting that the prior year's obligations incurred by the Office of the Register of Deeds, this city, for supplies, etc. be charged to current year appropriation;

WHEREAS, the Register of Deeds has clarified that the exact amount to be charged against current appropriation is P2,070.00 payable to Roginas News Magazine Store, this city;

WHEREAS, the City Budget Officer, through 3rd Indorsement dated 7 June 1996, has recommended that a resolution be passed by authorizing the City Accountant to charge the said amount of P2,070.00 to the Account- Provision for Prior Year's Obligations- a current appropriation;

WHEREAS, the City Accountant, through a Certification dated 18 June 1996, has stated that "Unobligated Allotments are available for the obligation described in the amount specified below:
