A RESOLUTION AUTHORIZING THE CITY ACCOUNTANT TO CHARGE PAYMENT IN THE AMOUNT OF TWO THOUSAND SEVENTY PESOS (#2,070.00) INCURRED BY THE OFFICE OF THE REGISTER OF DEEDS, TVIS CITY, FOR ITS PAYMENT TO ROGINAS NEWS STORE CHARGEABLE AGAINST THE PROVISIONS FOR THE PRIOR YEAR'S OBLIGATIONS- A CURRENT APPROPRIATION.

WNEREAS. this august Body is in receipt of a letter dated 30 April 1996 from the Office of the City Mayor requesting that the prior year's obligations incurred by the Office of the Register of Deeds, this city, for supplies, etc. be charged to current year appropriation;
