RESOLUTION APPROVING THE APPLICATION FOR PRELIMINARY APPROVAL AND LOCATIONAL CLEARANCE OF CAMELLA HOMES-ORMOC COMPRISING LOT NO. 5251-A, PSD-083738-006808-D AND LOT NO. 5257-B (LRC) PSD-229566, OWNED BY COMMUNITIES PHILIPPINES, INC., LOCATED AT BARANGAY TAMBULILID, ORMOC CITY WITH A TOTAL PROJECT AREA OF 67,841 SQUARE METERS, COVERED BY TRANSFER CERTIFICATES OF TITLE NOS. 26168 AND 14088, CONTAINING 338 SUBDIVISION LOTS EXCLUDING COMMUNITY FACILITIES, PARK AND PLAZA AND ROAD LOTS.


