ENDORSING WITH FULL SUPPORT HOUSE BILL NO. INTADDUCED BY CONGRESSMAN BERNARDO M. VERGARA, AN ACT GRANTING REGULATORY POWERS TO LOCAL IT (UN)TO OVER PUBLIC UTILITY AGENCIES BLE IN THE DELIVERY OF VITAL SERVICES LIKE POWER, TELEPHONE, TRANSPORTATION AND ENTITLED, GOVERNMENT RESPONSIBLE WATER, CONMUNICATIONS FACILITIES, AND FOR OTHER PURPOSES, ANENDING FOR THE PURPOSE THE PERTINENT PROVISIONS OF 7160, OTHERWISE KNOWN AS THE LOCAL GOVERNMENT CODE."

WHEREAS, this august Body is in receipt of Resolution No. 180 s. 1996 of the Sangguniang Panlungsod of Baguio City, entitled "SUPPORTING HOUSE BILL NO. 1711, INTRODUCED BY CONGRESSMAN BERNARDO M. VERGARA, ENTITLED, "AN ACT GRANTING REGULATORY POWERS TO LOCAL GOVERNMENT UNITS OVER PUBLIC UTILITY AGENCIES RESPONSIBLE IN THE DELIVERY OF VITAL SERVICES LIKE WATER, POWER, TELEPHONE, TRANSPORTATION AND COMMUNICATIONS FACILITIES, AND FOR OTHER PURPOSES, AMENDING FOR THE PURPOSE THE PERTINENT PROVISIONS OF R.A. 7160, OTHERWISE KNOWN AS THE LOCAL GOVERNMENT CODE.";

WHEREAS, the Seventh Sangguniang Panlungsod ng Ormoc, in SESSION, respectfully recommends that it strongly endorses and supports the said House Bill No. 1711, for it enhances the effectivity of every Local Government Unit in supervising the delivery of said vital services in the matter of petition for rate increases, hence, said especially request must be given due course of action;
