WHEREAS, it may be recalled that this Sanggunian has passed Resolution No. 96-78 dated 23 May 1996 entitled, "A RESOLUTION AUTHORIZING HONORABLE EUFROCINO M. CODILLA, SR., CITY MAYOR OF ORMOC, TO ENTER INTO A NEGOTIATED CONTRACT WITH HI-COOL ENGINEERING CORPORATION FOR THE INSTALLATION OF THE 400 TONS AIRCONDITIONING UNIT WITH COMPLETE ACCESSORIES FOR THE ORMOC COLISEUM IN THE AMOUNT NOT TO EXCEED \$246,800.00 AND ₱3,602,400.00 FOR THE INSTALLATION AND LIKewise TO OPEN A COMMERCIAL LETTER OF CREDIT WITH ANY GOVERNMENT BANK IN FAVOR OF HI-COOL ENGINEERING CORPORATION FOR THE SUPPLY OF 400 TONS AIRCONDITIONING UNIT WITH THE COMPLETE ACCESSORIES IN THE AMOUNT NOT TO EXCEED \$246,800.00 SO AS TO AVAIL OF THE TAX EXEMPTION";

WHEREAS, the Seventh Sangguniang Panlungsod upon review of said Contract and Agreement for the Supply and Installation of 400 Tons Airconditioning Unit for the Ormoc City Coliseum has considered said contract reasonable, hence must be given due course of action;

NOW, THEREFORE, on motion of Kagawad Claudio P. Larrazabal, Chairman, Committee on Infrastructures jointly seconded by Kagawad Benjamin B. Lladoc and Mariano Y. Corro; be it


