WHEREAS, for purposes of information and coordination, it is best that the Sangguniang Panlungsod be furnished with copies of the Executive Orders that the City Mayor may issue;

WHEREFORE, foregoing premises considered, on motion presented by Kagawad Mariano Y. Corro, Chairman, Committee on Laws and Ordinances, duly seconded by Kagawad Gregorio A. Yrastorza, Jr.; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution respectfully requesting the Honorable City Mayor Eufrocino M. Codilla, Sr., that henceforth, the Sangguniang Panlungsod ng Ormoc be furnished with copies of all the Executive Orders that he issues, for purposes of information and coordination;
