## RESOLUTION NO. 96-104

INFORMING THE SANGGUNIANG PAMBARANGAY OF BARANTAY CAMP DOWNES, THIS CITY, THROUGH ITS PUNONG BARANGAY RONORABLE DIOSDADA BALDIZANSO THAT THEIR RESOLUTION NO. 5, SERIES OF 1996, ENTITLED: RESOLUTION EARNESTLY REQUIRING RENTAL FEE TO BORROWER OF CARANGAY EQUIPMENTS BORROWED USED WITHIN OR OUTSIDE THE JURISDICTION OF BARANGAY CAMP DOWNES AND SHOULD BE RETURNED AFTER IT SERVE THE PURPOSE" MUST BE PASSED IN FORM OF AN ORDINANCE CONSIDERING THAT RESOLUTION GENERATES REVENUES AND FURTHER A PRIOR PUBLIC HEARING MUST BE CONDUCTED FOR THE PURPOSE TO WITH THE PERTINENT PROVISIONS OF THE LOCAL GOVERNMENT CODE OF 1991.

WHEREAS, this Sanggunian is in receipt of Resolution No. 5. Series of 1996, of the Sangguniang Pambarangay of Barangay Camp Downes, entitled: "A RESOLUTION EARNESTLY REQUIRING RENTAL FEE TO BORROWER OF BARANGAY EQUIPMENTS BORROWED USED WITHIN OR OUTSIDE THE JURISDICTION OF BARANGAY CAMP DOWNES AND SHOULD BE RETURNED AFTER IT SERVE THE PURPOSE";

the aforementioned resolution of the Sangguniang Pambarangay of Barangay Camp Downes is a revenue generating resolution, hence it must be passed in the form of an ORDINANCE as mandated by Section 132, of the Local Government Code of 1991, which provides: "The power to impose a tax, fee, or charge or to generate revenue under this Code shall be exercised by the sanggunian of the local government unit concerned through an appropriate ordinance" (Underscoring supplied for emphasis);

WHEREAS, Section 186 of the same Code, in part provides: "X X X Provided, further, That the ordinance levying such taxes, fees or charges shall not be enacted without any prior public hearing conducted for the purpose";

FOREGOING PREMISES CONSIDERED, on motion presented by Kagawad Mariano Y. Corro, Chairman, Committee on Laws and Ordinances, jointly seconded by mga Kagawad Benjamin B. Lladoc and Fernando P. Parmilla; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution informing the Sangguniang Pambarangay of Barangay Camp Downez, this City, through its Punong Barangay, Honorable Diosdada Baldizanso, that their Resolution No. 5, Series of 1996, entitled: "A RESOLUTION EARNESTLY REQUIRING RENTAL FEE TO BORROWER OF BARANGAY EQUIPMENTS BORROWED USED WITHIN OR OUTSIDE THE JURISDICTION OF BARANGAY CAMP DOWNES AND SHOULD BE RETURNED AFTER IT SERVE THE PURPOSE; must be passed in the form of an Ordinance, considering that said resolution generates revenues, and further, a prior public hearing must be conducted for the purpose to comply with the pertinent provisions of the Lacal Government Code of 1991;
