DISTRICT, THIS CITY, OF THE PLANS AND PROGRAMS OF WORK  
OF THE FOLLOWING PROPOSED PROJECTS:

- A. 1. REPAIR OF TWO (2) STOREY MODIFIED SCHOOL  
BUILDING, ORMOG CITY CENTRAL SCHOOL
- B. 1. IMPROVEMENT OF PALO-CARIGARA-ORMOC ROAD,  
ORMOC CITY
2. REHAB./RESURFACING OF JCT. NAT'L ROAD-  
MASARAYAO, NUEVA VISTA BRGY. ROAD, ORMOG CITY
3. CONSTRUCTION OF 2-CL SCHOOL BUILDING, ORMOG  
CITY HIGH SCHOOL

WHEREAS, this Sanggunian is in receipt of letters dated 1 July 1996  
and 2 July 1996, respectively from Engr. Ramon C. Omega, District  
Engineer 2nd LED, this city, said letters have both requested for  
approval of the Programs of Work on the Proposed Projects as afore-  
enumerated;

WHEREAS, of significance to state in here is City Ordinance No. 53  
s. 1995 entitled "AN ORDINANCE IMPLEMENTING THE PROVISION OF THE LOCAL  
GOVERNMENT CODE OF 1991 (R.A. 7160) REQUIRING MANDATORY COORDINATION AND  
CONSULTATION WITH THE APPROPRIATE LOCAL GOVERNMENT UNITS, NON  
GOVERNMENTAL AND PEOPLE'S ORGANIZATION AND OTHER CONCERNED SECTORS, AND  
APPROVAL OF THE SANGGUNIANG PANLUNGSOD NG ORMOG PRIOR TO THE  
IMPLEMENTATION OF NATIONALLY FUNDED PROJECTS/PROGRAMS, AND PROVIDING

PENALTIES FOR VIOLATIONS THEREOF", and Section 1 thereof has required "Prior Coordination, Consultation and Approval of the Sangguniang Panlungsod ng Ormoc in the Implementation of Nationally Funded Project/Program within the territorial jurisdiction of the City of Ormoc";

WHEREAS, this august Body through the representation of the Honorable Chairman Committee on Infrastructures has considered the aforesaid request of the District Engineer, 2nd LED, this city as meritorious and reasonable hence, must be accorded with due course of action;



- 3. Construction of 2-cl. Schoolbuilding, Ormoc City High School
