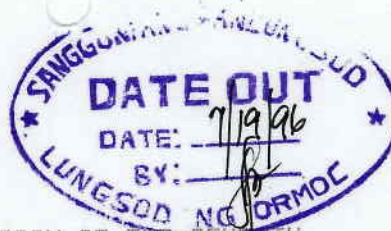


ENACTED, July 18, 1996.
