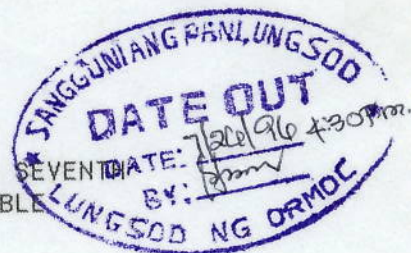

THE EXECUTIVE COMMITTEE, CITY DEVELOPMENT COUNCIL,
ENTITLED, "A RESOLUTION APPROVING THE REALIGNMENT OF
TWENTY MILLION PESOS (P20,000,000.00) FROM OUT OF THE
THIRTY MILLION PESOS (P30,000,000.00) APPROPRIATED FOR
THE RECLAMATION AREA PROJECT UNDER LAND AND LAND OUTLAY



CARRIED by Majority Votes with one (1) abstention registered by Kagawad Gregorio A. Yrastorza, Jr.


