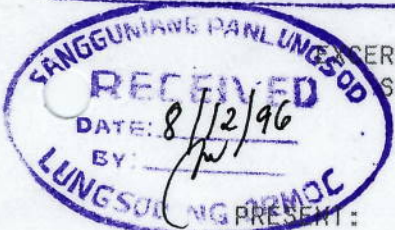

RESOLUTION NO. 96-125

A RESOLUTION APPROVING RESOLUTION NO. 5 S. 1996 OF THE  
CITY DEVELOPMENT COUNCIL (CDC) EXECUTIVE COMMITTEE,  
ENTITLED, "A RESOLUTION APPROVING THE REALIGNMENT OF  
CONSTRUCTION OF DOUBLE BARREL BOX CULVERT AT BARANGAY  
BAYOG IN THE AMOUNT OF FOUR HUNDRED NINETY FOUR  
THOUSAND SEVEN HUNDRED PESOS (P494,700.00) UNDER THE  
20% DEVELOPMENT FUND OF 1996, TO ADDITIONAL  
APPROPRIATION FOR THE CONSTRUCTION OF RCDG BRIDGE AT  
BARANGAY SAN JOSE IN THE AMOUNT OF FOUR HUNDRED NINETY  
FOUR THOUSAND SEVEN HUNDRED PESOS (P494,700.00) AND  
REQUESTING THE HONORABLE SANGGUNIANG PANLUNGSOD FOR  
APPROPRIATION OF THE SAME.

WHEREAS, this Sanggunian is in receipt of the City Development  
Council (CDC) Executive Committee Resolution No. 5 s. 1996, entitled, "A  
Resolution approving the realignment of construction of Double Barrel  
Box Culvert at Barangay Bayog in the amount of Four Hundred Ninety Four  
Thousand Seven Hundred Pesos (P494,700.00) under the 20% Development  
Fund of 1996, to additional appropriation for the construction of RCDG  
Bridge at Barangay San Jose in the amount of Four Hundred Ninety Four  
Thousand Seven Hundred Pesos (P494,700.00) and requesting the Honorable  
Sangguniang Panlungsod for approval of the same";

WHEREAS, said CDC Executive Committee Resolution No. 5 s. 1996 has  
requested this Sanggunian for approval of the realignment of the  
aforementioned project in the amount of P494,700.00 for current year;

WHEREAS, this august Body has verified and affirmed that the  
construction of the RCDG Bridge at Brgy. San Jose is urgently needed to  
meet the demands of the public, and that additional funds for its  
completion is a MUST since "the allocated amount of P6,700,000.00, as



approved, is not sufficient to finish the project". On the other hand, the proposed "construction of Double Barrel Box Culvert at Brgy. Bayog cannot be implemented, for upon verification, it has been found out that the proposed site of the project has no road right of way";

NOW, THEREFORE, on motion of Kagawad Claudio P. Larrazabal, Chairman, Committee on Infrastructures, duly seconded by Kagawad Benjamin B. Lladoc; be it

RESOLVED, to pass a resolution APPROVING RESOLUTION NO. 5 S. 1996 OF THE CITY DEVELOPMENT COUNCIL (CDC) EXECUTIVE COMMITTEE, ENTITLED, "A RESOLUTION APPROVING THE REALIGNMENT OF CONSTRUCTION OF DOUBLE BARREL BOX CULVERT AT BARANGAY BAYOG IN THE AMOUNT OF FOUR HUNDRED NINETY FOUR THOUSAND SEVEN HUNDRED PESOS (P494,700.00) UNDER THE 20% DEVELOPMENT FUND OF 1996, TO ADDITIONAL APPROPRIATION FOR THE CONSTRUCTION OF RCDG BRIDGE AT BARANGAY SAN JOSE IN THE AMOUNT OF FOUR HUNDRED NINETY FOUR THOUSAND SEVEN HUNDRED PESOS (P494,700.00) AND REQUESTING THE HONORABLE SANGGUNIAN PANLUNGSOD FOR APPROPRIATION OF THE SAME;

ENACTED, August 08, 1996.

RESOLVED, FURTHER, to furnish copies of this resolution, one each, to His Honor, the City Mayor; the City Administrator, the City Treasurer, the City Budget Officer, the City Accountant, the City Engineer, the City Planning & Development Office and the City Auditor, -all in Ormoc City;

CARRIED by MAJORITY VOTES, with eight (8) affirmative votes, and two (2) abstentions registered by mga Kagawad Celso P. Adolfo and Gregorio A. Yrastorza, Jr.
