A RESOLUTION APPROVING RESOLUTION NO. 6 S. 1996 OF THE
CITY DEVELOPMENT COUNCIL (CDC) EXECUTIVE COMMITTEE,
ENTITLED, "A RESOLUTION APPROVING THE REALIGNMENT OF
THE FOLLOWING PROJECTS: A.) RECLAMATION AREA PROJECT
(P10,000,000.00) B.) ROAD OPENING AT BARANGAY BAYOG
(P116,328.00); C.) RIPRAPING AT BARANGAY CAN-ADIENG
(P200,000.00); D.) RESURFACING @ BARANGAY LIBERTY
(P250,000.00); AND E.) ADDITIONAL APPROPRIATION FOR
MALBASAG DOWNSTREAM (P50,000.00) WITH A TOTAL AMOUNT OF
TEN MILLION SIX HUNDRED SIXTEEN THOUSAND THREE HUNDRED

SANGGUNIANG PANLUNGSOD FOR APPROVAL OF THE SAME."

WHEREAS, this Sanggunian is in receipt of the City Development
Council (CDC) Executive Committee Resolution No. 6 s. 1996, entitled, "A
RESOLUTION APPROVING THE REALIGNMENT OF THE FOLLOWING PROJECTS: A.)
RECLAMATION AREA PROJECT (P10,000,000.00) B.) ROAD OPENING AT BARANGAY
BAYOG (P116,328.00); C.) RIPRAPING AT BARANGAY CAN-ADIENG (P200,000.00);
D.) RESURFACING @ BARANGAY LIBERTY (P250,000.00); AND E.) ADDITIONAL
APPROPRIATION FOR MALBASAG DOWNSTREAM (P50,000.00) WITH A TOTAL AMOUNT
OF TEN MILLION SIX HUNDRED SIXTEEN THOUSAND THREE HUNDRED TWENTY EIGHT
PESOS (P10,616,328.00) UNDER THE 20% DEVELOPMENT FUND OF 1996 TO THE
FOLLOWING PROJECTS: A.) LOT ACQUISITION FOR RESETTLEMENT SITE,

(P5,000,000.00); B.) ADDITIONAL APPROPRIATION FOR CONSTRUCTION OF PUBLIC MARKET BLDG. (P5,000,000.00); AND C.) ADDITIONAL APPROPRIATION FOR RCDG BRIDGE AT BARANGAY LABRADOR (P616,328.00) WITH TOTAL AMOUNT OF TEN MILLION SIX HUNDRED SIXTEEN THOUSAND THREE HUNDRED TWENTY EIGHT PESOS (P10,616,328.00) AND REQUESTING THE HONORABLE SANGGUNIAN PANLUNGSOD FOR APPROVAL OF THE SAME";

WHEREAS, said CDC Executive Committee Resolution No. 6 s. 1996, copy of same is hereto attached, has cited justifications of these realignments which are quoted hereunder, as follow:

"X X X Road Opening at Brgy. Bayog is deferred due to Road Right of Way problem; Ripraping of Brgy. Can-adieng cannot be implemented for the year 1996 due to revision of design of the structure; Road Surfacing of Brgy. Liberty can be implemented thru Barangay Road Maintenance Fund; and Additional appropriation for Malbasag Downstream is not necessary for the project is already completed.

"X X X Reclamation Area project (P10,000,000.00) is put into shelve to give more priority to the urgent needs of the public.

"X X X lot acquisition of a resettlement site (P5,000,000.00) is needed for the relocation of the affected dwellers of the Flood Mitigation Project of Ormoc City which is now being considered for funding by the Japanese Government for 1997;

"X X X additional appropriation for Construction of Public Market Building (P5,000,000.00) is necessary due to revision of design of the building;

"X X X additional appropriation (P616,328.00) is also urgently needed for the Construction of RCDG Bridge at Brgy. Labrador for the reason that the appropriated amount of Three Million Two Hundred Thousand Pesos (P3,200,000.00) approved by the City Development Council last May 20, 1996, will not suffice to finish the project.

"X X X the Executive Committee has approved the proposed realignments since these projects are considered to be of immediate importance to the city and has to be implemented the soonest possible time;"

NOW, THEREFORE, foregoing premises considered, on motion of Kagawad Claudio P. Larrazabal, Chairman, Committee on Infrastructures, jointly seconded by mga Kagawad Sotero M. Pepito and Benjamin B. Lladoc; be it

RESOLVED, to pass a resolution APPROVING RESOLUTION NO. 6 S. 1996 OF THE CITY DEVELOPMENT COUNCIL (CDC) EXECUTIVE COMMITTEE, ENTITLED, "A RESOLUTION APPROVING THE REALIGNMENT OF THE FOLLOWING PROJECTS: A.) RESURFACING @ BARANGAY LIBERTY (P250,000.00); AND E.) ADDITIONAL APPROPRIATION FOR MALBASAG DOWNSTREAM (P50,000.00) WITH A TOTAL AMOUNT OF TEN MILLION SIX HUNDRED SIXTEEN THOUSAND THREE HUNDRED TWENTY EIGHT PESOS (P10,616,328.00) UNDER THE 20% DEVELOPMENT FUND OF 1996 TO THE FOLLOWING PROJECTS: A.) LOT ACQUISITION FOR RESETTLEMENT SITE (P5,000,000.00); B.) ADDITIONAL APPROPRIATION FOR CONSTRUCTION OF

PUBLIC MARKET BLDG. (P5,000,000.00); AND C.) ADDITIONAL APPROPRIATION FOR RCDG BRIDGE AT BARANGAY LABRADOR (P616,328.00) WITH TOTAL AMOUNT OF TEN MILLION SIX HUNDRED SIXTEEN THOUSAND THREE HUNDRED TWENTY EIGHT PESOS (P10,616,328.00) AND REQUESTING THE HONORABLE SANGGUNIANG PANLUNGSOD FOR APPROVAL OF THE SAME.";
