RESOLUTION NO.

A RESOLUTION RESPECTFULLY URGING THE REGIONAL TECHNICAL DIRECTOR, LANDS MANAGEMENT SERVICE, DEPARTMENT OF DIRECTOR, ENVIRONMENT AND NATURAL RESOURCES, REGION 08, TACLOBAN CITY, TO RESOLVE WITH DISPATCH THE PENDING BOUNDARY CITY, TO RESOLVE WITH DISPATCH THE PENDING BOUNDARY DISPUTE BETWEEN THE CITY OF ORMOC AND THE MUNICIPALITY OF KANANGA, LEYTE.

WHEREAS, there is now a pending boundary dispute between the City of Ormoc and the Municipality of Kananga before the Office of the Regionary of Environment hal Technical Director, Lands Management Service, Department of Environment and Natural Resources, Region 08, Tacloban City;

₩ÆREAS, the parties thereto have long submitted their respective position papers in the form of Manifestation for the Municipality of Kananga, and Counter-Memorandum for the City of Ormoc, through their respective counsels;

WHEREAS, it would be to the best interest of all concerned that this matter be resolved with dispatch especially that the issue involved therein is of much concern and significance to the LGUs involved;

WHEREFORE, on motion duly presented by Kagawad Mariano Y. Corro, Chairman, Committee on Public Properties, severally seconded by mga Kagawad Benjamin B. Lladoc, Sotero M. Pepito, Alfredo F. Capahi and Jose C. Alfaro, Jr.; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a Resolution respectfully urging the Regional Technical Director, Lands Management Service, Department of Environment and Natural Resources, Region 08, Tacloban City, to resolve with dispatch the pending boundary dispute between the City of Ormoc and the Municipality of Kananga, Leyte;
