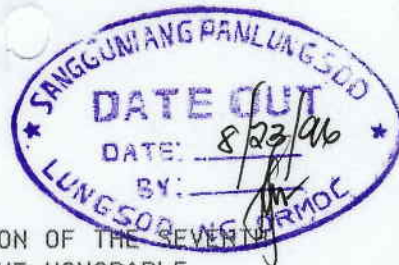

SEVILLANO DE LA CRUZ, REGIONAL DIRECTOR, DEPARTMENT OF EDUCATION, CULTURE AND SPORTS (DECS), REGION 08, CANDAHUG, PALO, LEYTE, (WITH COPY FURNISHED THE HONORABLE SECRETARY RICARDO T. GLORIA, DECS, MANILA), FOR THE OPENING OF BARANGAY HIGH SCHOOLS IN BARANGAY LINAO AND BARANGAY DOLORES, THIS CITY.

WHEREAS, the Ormoc National High School, this city, is yearly over-crowded with High School enrollees;

WHEREAS, Barangay Linao and Barangay Dolores of Ormoc City have, each, set aside one (1) hectare of Barangay site for the proposed High School site;

WHEREAS, there are more than enough elementary graduates from Barangay Linao and its neighboring barangays and in Barangay Dolores and its neighboring barangays to guarantee enough enrollees in the proposed barangay high schools;
