RESOLUTION NO. 96-137

RESOLUTION RESPECTFULLY URGING CONGRESS OF THE CHILIPPINES TO ENACT INTO LAW SENATE BILL TO SOCIAL ENTITLES, "AN ACT FURTHER STRENGTHENING THE SOCIAL AMENDING FOR THIS PURPOSE SECURITY SYSTEM THEREBY AMENDING FOR THIS PURPOSE REPUBLIC ACT NO. 1161, AS AMENDED, OTHERWISE KNOWN AS THE SOCIAL SECURITY LAW", INTRODUCED BY SENATOR ALBERTO ROMULO.

WHEREAS, there is now pending in the Philippine Senate, Senate Bill 1278, entitled, "AN ACT FURTHER STRENGTHENING THE SOCIAL SECURITY SYSTEM THEREBY AMENDING FOR THIS PURPOSE REPUBLIC ACT NO. 1161, AS AMENDED, OTHERWISE KNOWN AS THE SOCIAL SECURITY LAW", introduced by Senator Alberto G. Romulo;

WHEREAS, the Explanatory Note of aforecited bill, states among others, to wit: "X X X it also seeks to increase the minimum monthly pension as follows: \$1,000.00 for death and disability pensioners; P2,000.00 for all pensioners with 10 credited years of service; and #3,000.00 for those with 20 credited years of service. Funeral benefit is also increased from P10,000.00 to P12,000.00" (This is embodied in Section 11 of Senate Bill 1278)

WHEREAS, Section 12 of said Senate Bill No. 1278, likewise increased the Dependents' pension "equivalent to ten percent of the monthly pension or one hundred fifty pesos, whichever is higher"

WHEREAS, the present value of the benefits enjoyed by members of the Social Security System has been greatly eroded brought about by the low purchasing power of the peso, hence, must be up-graded in order to

catch up with the high cost of living nowadays, especially that most of the SSS pensioners are wholly dependent for their livelihood upon the pension that they received;

WHEREAS, the Social Security System will celebrate its 39th Anniversary on September 1, 1996, so on this milestone of the existence of SSS, it would be a very fitting gesture, and this will be greatly appreciated by the members of SSS, if the different benefits provided for in the SS Law, as contemplated in Senate Bill No. 1161, will now be upgraded;

WHEREFORE, foregoing premises considered, on motion of Magawad Mariano Y. Corro, Chairman, Committee on Laws and Ordinances, severally seconded by mga Kagawad Fernando P. Parrilla, Gregoria A. Yrastorza, Jr. and Celso P. Adolfo; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution RESPECT-FULLY URGING CONGRESS OF THE PHILIPPINES TO ENACT INTO LAW SENATE BILL NO. 1278, ENTITLED, "AN ACT FURTHER STRENGTHENING THE SOCIAL SECURITY SYSTEM THEREBY AMENDING FOR THIS FURPOSE REPUBLIC ACT NO. 1161, AS AMENDED, OTHERWISE KNOWN AS THE SOCIAL SECURITY LAW", INTRODUCED BY SENATOR ALBERTO G. ROMULO;
