RESOLUTION NO. 96-138

A RESOLUTION APPROVING ORDINANCE NO. 96-001 S. 1996 OF BARANGAY DISTRICT 17, THIS CITY, ENTITLED, "AN ORDINANCE PROHIBITING RESIDENTS OF THIS BARANGAY FROM THE INDISCRIMINATE THROWING OF GARBAGE, AND/OR UNSANITARY DISPOSAL OF ANY WASTE MATERIALS AND PROVIDING PENALTIES THEREOF."

WHEREAS, the Sangguniang Panlungsod ng Ormoc is in receipt of Resolution No. 96-005 s. 1996 from Barangay District 17, this city, embodying Ordinance No. 96-001 entitled, "An Ordinance prohibiting residents of this barangay from the indiscriminate throwing of garbage, and/or unsanitary disposal of any waste materials and providing penalties thereof";

WHEREAS, this Sanggunian, in relation with the aforecited Ordinance at issue, is by law mandated to review on whether the said Ordinance is consistent with law and city X X X ordinance, (Sec. 57 LGC 1991);

WHEREAS, this august Body, through the representation of the Honorable Chairman, Committee on Laws & Ordinances, has observed that the said Ordinance has conformed to the pertinent provisions of the Local Government Code, hence, reasonable and within the province of the Sangguniang Barangay of Barangay District 17 to legislate;

NOW, THEREFORE, on motion of Kagawad Mariano Y. Corro, Chairman, Committee on Laws & Ordinances, duly seconded by Kagawad Claudio P. Larrazabal; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to approve Ordinance No. 96-001 s. 1996 of Barangay District 17, this city, entitled, "An Ordinance prohibiting residents of this barangay from the indiscriminate throwing of garbage, and/or unsanitary disposal of any waste materials and providing penalties thereof";
