WHEREAS, the decision of the Court of Appeals, in CA G.R. No. 50652-R, entitled, "CITY OF ORMOC, versus, GENOVEVA BANTASAN, ET. AL." EMINENT DOMAIN, has long become final and executory (June 20, 1979, yet);

WHEREAS, the parcels of land expropriated have not been fully utilized by the City Government of Ormoc, as there are still a big portion thereof which remains vacant, and some lots or portions thereof are now occupied by private individuals;

WHEREAS, this Sanggunian has received several requests from private individuals to release some lots or portions thereof; however, this Sanggunian, so far, has turned down all these requests;

WHEREAS, this Sanggunian feels that a serious study should be made on the actual and future use of the parcels of land expropriated, which were intended "for use as a government center where public buildings may

be constructed" for their information and guidance relative to the request for the release of lots or portions thereof by private individuals;

WHEREFORE, foregoing premises considered, on motion duly presented by Kagawad Mariano Y. Corro, Chairman, Committee on Public Properties, duly seconded by mga Kagawad Claudio P. Larrazabal and Gregorio A. Yrastorza, Jr.; be it,
