RESOLUTION NO. 96-147

A RESOLUTION, AUTHORIZING THE HONORABLE CITY MAYOR EUFROCING A CODILLA, SR., TO NEGOTIATE AND ENTER INTO A CONTRACT FOR PURPOSES OF SECURING A LOAN FROM EITHER OF THE GOVERNMENT BANKS IN THE CITY OF ORMOC (LAND BANK OR DRP) IN THE AMOUNT OF ONE HUNDRED MILLION PESOS (P100,000,000.00) FOR THE CONSTRUCTION OF THREE (3) PUBLIC MARKET EUILDINGS.

WHEREAS, this august Body is in receipt of a letter dated 26 August 1998 from the Honorable City Mayor Eufrocino M. Codilla, Sr., the full text of which is hereunder cited as follows:

To accommodate the ever increasing buying public and help decongest the overcrowded existing market and minimize if not eliminate the presence of sidewalk vendors, the

undersigned considers the construction of three (3) public market buildings as priority project of the City Government.

In view of the above, may I request authority from that august Body that I be allowed to obtain a loan from either of the government bank in our City (Landbank or DBP) in the amount of ONE HUNDRED MILLION PESOS (\$100,000,000.00) to finance the above project.

WHEREAS, per information from the City Planning and Development Coordinator, said project was included in the Local Development Plan of the City of Ormoc approved by this august Body through SP Resolution No. 07 dated 14 January 1993;

WHEREAS, of significance to state in here is Rule XXXIII, Article 394 of the Rules and Regulations Implementing the Local Government Code of 1991 which provides:

RULE XXXIII
Local Government Code Credit Financing

X X X

ART. 394. General Policy - (a) Any LGU may create indebtedness, and avail of credit facilities to finance infrastructure and other socio-economic development projects in accordance with the approved local development plan and public investment program. (b) An LGU may avail of credit lines from government or private banks and lending institutions for the purpose of stabilizing local finance".

Chairman, Committee on Finance severally seconded by mga Kagawad Sotero M. Pepito, Chiqui B. Labagala and Celso P. Adolfo; be it

RESOLVED, to pass a resolution AUTHORIZING THE HONORABLE CITY MAYOR EUFROCINO M. CODILLA, SR., TO NEGOTIATE AND ENTER INTO A CONTRACT FOR PURPOSES OF SECURING A LOAN FROM EITHER OF THE GOVERNMENT BANKS IN THE CITY OF ORMOC (LAND BANK OR DBP) IN THE AMOUNT OF ONE HUNDRED MILLION PESOS (\$100,000,000.00) FOR THE CONSTRUCTION OF THREE (3) PUBLIC MARKET BUILDINGS;
