RESOLUTION NO. 96-152

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EUFROCINO M. CODILLA, SR. TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, A DEED OF DONATION IN FAVOR OF THE ORMOC FEDERATION OF SENIOR CITIZENS INVOLVING A PARCEL OF LAND OF THE CITY GOVERNMENT OF ORMOC SITUATED AT THE CITY GOVERNMENT CENTER (COGON COMBADO), ORMOC CITY, COVERING A PORTION OF PCN-08-000008 WITH AN AREA OF FIVE HUNDRED (500) SQUARE METERS, TO BE USED AS SITE FOR THE ORMOC FEDERATION OF SENIOR CITIZENS CENTER; PROVIDED, THAT THE CONSTRUCTION OF THE BUILDING OF SAID FEDERATION CENTER SHALL COMMENCE WITHIN ONE (1) YEAR FROM THE DATE OF ACCEPTANCE OF THE SAID DONATION, AND, PROVIDED FURTHER, THAT ON THE EVENTUALITY THAT THE PURPOSE FOR WHICH THE DONATION IS INTENDED CEASES, OR, FAILURE ON THE PART OF THE DONEE TO CONSTRUCT THE BUILDING AT SAID FEDERATION CENTER WITHIN THE PRESCRIBED TIME SHALL RESULT IN THE REVERSION OF OWNERSHIP OF SAID PROPERTY WITH ALL ITS IMPROVEMENT TO THE CITY GOVERNMENT OF ORMOC, AS THE CASE MAY BE.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement (letter) dated 3 September 1996 from the Honorable City Mayor requesting for passage of a resolution authorizing him to sign, for and in behalf of the City Government of Ormoc, a Deed of Donation with the Ormoc Federation of Senior Citizens involving a parcel of land at the City Government Center, covering a portion of Pcn-08-000008 with an area of 500 square meters to be used as site for the Ormoc Federation of Senior Citizens Center, with the full text of said 1st Indorsement hereunder cited:

Respectfully forwarded to Hon. Benjamin F. Tugonon, Vice Mayor & Presiding Officer, Sangguniang Panlungsod, Ormoc City, the attached DEED OF DONATION involving a parcel of land of the City Government of Ormoc situated at the City Government Center (Cogon Combado), Ormoc City, covering a portion of Pcn-08-000008 with an area of Five Hundred (500) sq. meters to be used as site for the Ormoc Federation of Senior Citizens Center.

Anent this, it is respectfully requested of that august Body to pass a resolution authorizing the City Mayor to sign for and in behalf of the City Government of Ormoc the said Deed of Donation.


RESOLVED, AS IT IS HEREBY RESOLVED, to authorize the Honorable City Mayor Eufrocino M. Codilla, Sr. to sign, for and in behalf of the City Government of Ormoc, a Deed of Donation in favor of the Ormoc Federation of Senior Citizens involving a parcel of land of the City Government of Ormoc situated at the City Government Center (Cogon Combado), Ormoc City, covering a portion of Pcn-08-000008 with an area of five hundred (500) square meters, to be used as site for the Ormoc Federation of Senior Citizens; PROVIDED, that the construction of the building of said Federation Center shall commence within one (1) year from the date of acceptance of the said donation, and, PROVIDED FURTHER, that on the eventuality that the purpose for which the donation is intended ceases, or, failure on the part of the donee to construct the building at said Federation Center within the prescribed time shall result in the reversion of ownership of said property with all its improvement to the City Government of Ormoc as the case may be;
