## RESOLUTION NO. 96-154

A RESOLUTION APPROVING ORDINANCE NO. 06-001 S. 1996 OF BARANGAY LIBERTY, THIS CITY, ENTITLED, "AN ORDINANCE PROMIBITING THE USE OF INSECTICIDES AND OTHER POISONOUS SUBSTANCES IN RIVERS, STREAMS, AND OTHER PUBLIC WATERS, WITHIN THE JURISDICTION OF THIS BARANGAY, FOR THE PURPOSE OF CATCHING FISHES, AND OTHER AQUATIC RESOURCES, PROHIBITING PENALTIES THEREOF.

REAS, this august Body is in receipt of Ordinance No. 06-001 s. 1990 of the Barangay Council of Brgy. Liberty, this city, entitled, "An Ordinance prohibiting the use of insecticides and other poisonous substances in rivers, streams, and other public waters, within the jurisdiction of this barangay, for the purpose of catching fishes, and other aquatic resources, providing penalties thereof.";

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the aforecited Ordinance at issue, (and all other ordinances from all mga barangay of Ormoc City), is, by law mandated to review on whether the said ordinance is consistent with law and other city X X X ordinances. (Sec. 57 LGC 1991);

WHEREAS, this august Body, through the representation of the Honorable Chairman, Committee on Laws & Ordinance, has observed that said ordinance has conformed to the pertinent provisions of the Local Government Code, hence, reasonable and within the province of the Sangguniang Barangay of Brgy. Liberty to legislate;

NOW, THEREFORE, on motion of Kagawad Mariano Y. Corro, Chairman, Committee on Laws & Ordinances, jointly seconded by mga Kagawad Benjamin B. Lladoc and Fernando P. Parrilla; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to approve Ordinance NO. 06-001 s. 1996 of Barangay Liberty, this city, entitled, "An Ordinance prohibiting the use of insecticides and other poisonous substances in rivers, streams, and other public waters, within the jurisdiction of this barangay, for the purpose of catching fishes, and other aquatic resources, providing penalties thereof.";
