WHEREAS, this Sanggunian is in receipt of Ordinance No. 96-003 s. From the Barangay Council of Brgy. Liberty, this city, entitled, "An Ordinance imposing a curfew, to all persons, within the jurisdiction of this barangay from 9:00 o'clock in the evening to 5:00 o'clock in the morning of the following day, providing penalties and exceptions thereof";
