RESOLUTION NO. 96-155

A RESOLUTION APPROVING ORDINANCE NO. 96-003 S. 1996 OF BARANGAY LIBERTY, THIS CITY, ENTITLED, "AN ORDINANCE IMPOSING A CURFEW, TO ALL PERSONS, WITHIN THE JURISDICTION OF THIS BARANGAY, FROM 9:00 O'CLOCK IN THE EVENING TO 5:00 O'CLOCK IN THE MORNING OF THE FOLLOWING DAY, PROVIDING PENALTIES AND EXCEPTIONS THEREOF".

WHEREAS, this Sanggunian is in receipt of Ordinance No. 96-003 s. 1996 from the Barangay Council of Brgy. Liberty, this city, entitled, "An Ordinance imposing a curfew, to all persons, within the jurisdiction of this barangay from 9:00 o'clock in the evening to 5:00 o'clock in the morning of the following day, providing penalties and exceptions thereof";

WHEREAS, this august Body, through the representation of the Honorable Chairman, Committee on Laws & Ordinances, has observed that said ordinance has conformed to the pertinent provisions of the Local Government Code, hence, reasonable and within the province of the Barangay Council of Liberty to legislate;
