INFORMING DOMA JOSEFA S. SERAFICA AND THE RESCLUTION HEIRS OF KIRMENEGILDO SERAFICA THAT THE CITY GOVERNMENT OF ORMOG DOES NOT INTERPOSE ANY OBJECTION TO THE TRANSVERSING LOT NO. 8123 SITUATED AT BARANGAY CATAYUM, CRMOC CITY, TO V & G BETTER HOMES SUBDIVISION.
