RESOLUTION NO. 96-156

A RESOLUTION INFORMING DOÑA JOSEFA S. SERAFICA AND THE HEIRS OF HERMENEGILDO SERAFICA THAT THE CITY GOVERNMENT OF ORMOC DOES NOT INTERPOSE ANY OBJECTION TO THE ESTABLISHMENT OF A PERPETUAL EASEMENT OF RIGHT OF WAY TRANSVERSING LOT NO. 8123 SITUATED AT BARANGAY CATAYUM, ORMOC CITY, TO V & G BETTER HOMES SUBDIVISION.

WHEREAS, this Sanggunian is in receipt of letter dated 28 August 1996 from Doña Josefa S. Serafica, the full text of said letter is hereunder cited as follows:

I and the Heirs of Hermenegildo Serafica has executed a Deed of Agreement for Perpetual Easement of Right of Way transversing Lot #8123, situated at Barangay Catayum, Ormoc City to V & G Better Homes Subdivision Inc., Tacloban City.

In this connection, may we request an affirmation from the City Government of Ormoc City that it does not interpose

any objection to said road that transverses Lot # 8123 situated at Barangay Catayum, Ormoc City.
