AUTHORIZING THE HONORABLE CITY RESOLVITION RESOLUTION AUTHORIZING THE HUNDRABLE CITY PHOTOR EUFROCING M. CODILLA, SR. TO SIGN, FOR AND IN BEHALF OF WE CITY GOVERNMENT OF ORMOC, A MEMORANDUM OF AGREEMENT (MCA) WITH THE PRESIDENTIAL COMMISSION FOR THE URBAN FOOR, REPRESENTED BY ITS CHAIRMAN, MELCHIZEDEK Y. MAQUISO FOR THE STRENGTHENING OF THE URBAN POOR AFFAIRS OFFICE OF THE CITY OF ORMOC.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement (letter) September 1996 from the Honorable City Mayor, with an unsigned copy of a MOA or Memorandum of Agreement to be entered into between the Presidential Commission for the Urban Poor and the City Government of Ormoc, and said 1st Indorsement has requested this august Body for passage of a resolution authorizing him to sign the said MOA for and in behalf of the City Government of Ormoc:

WHEREAS, the Honorable MEMBERS of the SANGGUNIANG PANLUNGSOD ng ORMOC, in SESSION, have considered the request of the Honorable City Mayor very reasonable, for the bases for which MOA for the Strengthening of the Urban Poor Affairs Office in Ormoc City are legal constitutional, hence, said request must be accorded with due course of action;

NOW, THEREFORE, on motion of Kagawad Manuel T. Fiel, Chairman, Committee on Urban Development, jointly seconded by mga Kagawad Benjamin B. Lladoc and Chiqui B. Labagala; be it

RESOLVED, to pass a resolution AUTHORIZING THE HONORABLE CITY MAYOR EUFROCINO M. CODILLA, SR. TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, A MEMORANDUM OF AGREEMENT (MOA) WITH THE PRESIDENTIAL COMMISSION FOR THE URBAN POOR, REPRESENTED BY ITS CHAIRMAN, MELCHIZEDEK Y. MAQUISO, FOR THE STRENGTHENING OF THE URBAN POOR AFFAIRS OFFICE OF THE CITY OF ORMOC;
