A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EUFROCINO M. CODILLA, SR., REPRESENTING THE CITY GOVERNMENT OF ORMOC AND AS CHAIRMAN OF THE CITY NUTRITION COUNCIL AND AS C.R.O.W.N. AWARDEE, TO SIGN A MEMORANDUM OF AGREEMENT (MOA) WITH THE NATIONAL NUTRITION COUNCIL REPRESENTED BY ITS EXECUTIVE DIRECTOR, ELSA M. BAYANI, FOR THE IMPLEMENTATION OF PROJECTS AND ACTIVITIES FOR NUTRITION IMPROVEMENT.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement (letter) dated 5 September 1996 from the Honorable City Mayor, with an unsigned copy of a MOA or Memorandum of Agreement to be entered into between the National Nutrition Council and the City Government of Ormoc, and said 1st Indorsement has requested this august Body for passage of a resolution authorizing him to sign the said MOA for and in behalf of the City Government of Ormoc;

WHEREAS, the Honorable Members of the Sangguniang Panlungsod, in SESSION, have considered valid and reasonable the general intent and purpose of said MOA which stand to recognize the mandates and needs, and the implementation of projects and activities for nutrition improvement;
