RESOLUTION NO. 96-159

A RESOLUTION STRONGLY SUPPORTING RESOLUTION NO. 96-006 OF BARANGAY STO. NINO "PROHIBITING LIDE MANAGEMENT CORPORATION (LMC), FROM TAPPING THE WATER FROM THE WELL DRILLED WITHIN THE JURISDICTION OF THIS BARANGAY, AND CONNECTING THE SAME TO THEIR EXISTING WATER SYSTEM, WITHOUT THE PROPER CONSULTATIONS AND APPROVAL OF THIS COUNCIL".

WHEREAS, Sangguniang Panlungsod of Ormoc is in receipt of a copy of Resolution No. 96-006 of Barangay Sto. Niño "PROHIBITING LIDE MANAGEMENT CORPORATION (LMC), FROM TAPPING THE WATER FROM THE WELL DRILLED WITHIN THE JURISDICTION OF THIS BARANGAY, AND CONNECTING THE SAME TO THEIR EXISTING WATER SYSTEM, WITHOUT THE PROPER CONSULTATIONS AND APPROVAL OF THIS COUNCIL";

WHEREAS, this august Body previously passed a resolution condemning the drilling for LMC formerly known as LWSS, done without prior consultation and approval from the Barangay, Res. No. 221, "A RESOLUTION STRONGLY CONDEMNING THE WATER DRILLING CONDUCTED BY THE LWSS AT BARANGAY STO. NINO WHICH IS DONE WITHOUT PERMIT FROM THE BARANGAY COUNCIL AND FROM THE OFFICE OF THE CITY MAYOR, AND SUPPORTING THE RESOLUTION OF THE BARANGAY COUNCIL OF STO. NINO MANIFESTING VEHEMENT DISAPPROVAL ON THE ON-GOING WATER DRILLING CONDUCTED BY THE LWSS AT BARANGAY STO. NINO, ORMOC CITY;

WHEREAS, unregulated and uncontrolled drawing of water from deep wells will adversely affect the aquifers and water table of Ormoc City area;

WHEREAS, above premises considered, on MASS MOTION of the BODY and with OVERWHELMING SECONDS, so be it

RESOLVED, AS IT IS HEREBY RESOLVED, to strongly support Res. No. 96-006 of Barangay Sto. Niño "prohibiting LIDE Management Corporation (LMC), from tapping the water from the well drilled within the jurisdiction of this barangay, and connecting the same to their existing water system, without the proper consultations and approval of this council";

RESOLVED, FURTHER, to require LMC to also get the approval of the Sangguniang Panlungsod of Ormoc in accordance with Ordinance No. 53 series of 1995;

ENACTED, September 12, 1996.

RESOLVED, FINALLY, to furnish copies of this resolution each to His Honor, the City Mayor; the City Administrator, the City Legal Officer, the LIDE Administrator, LIDE Management Corporation (LMC), Isabel, Leyte; the Executive Director, National Water Resources Board, 7th Floor NIA Bldg., EDSA, Quezon City; the Regional Director, DENR, Tacloban City; the City Prosecutors' Office of Ormoc; the City Director, PNP of Ormoc; the Brgy. Chairman & Brgy. Secretary of Brgy. Sto. Niño, and other Offices concerned;
