A RESOLUTION RETURNING TO THE OFFICE OF THE CITY PLANNING AND DEVELOPMENT COORDINATOR, THIS CITY, THE PAPERS/DOCUMENTS OF MR. ARMANDO JASMIN RELATIVE TO HIS APPLICATION FOR A BUILDING PERMIT TO IMPROVE/RENOVATE HIS CORE SHELTER AWARDED TO HIM BY THE WORLD VISION INTERNATIONAL AT THE ORMOC CITY GOVERNMENT OWNED LOT AT BRGY. IPIL, THIS CITY, WITH THE INFORMATION THAT THIS SANGGUNIANG INTERPOSES NO OBJECTION TO SAID APPLICATION PROVIDED THAT THE CITY GOVERNMENT OF ORMOC RETAINS OWNERSHIP OF THE PARCEL OF LAND WHERE MR. JASMIN'S BUILDING IS LOCATED.

PRESENTED to this august Body for consideration is an Application for a Building Permit of Mr. Armando Jasmin located at the World Vision Resettlement Project of the City of Ormoc in Barangay Ipil, this city.

WHEREAS, the City Planning and Development Coordinator, through 1st Indorsement dated 5 September 1996, has referred the said application to the Honorable Chairman, Committee on Public Properties, with the information that the lot applied for building permit is owned by the City Government of Ormoc and that only occupancy permit was issued to the applicant;

WHEREAS, this august Body, in SESSION, through the representation of the Honorable Chairman, Committee on Public Properties, interposes no objection to the said application for building permit to improve/renovate the applicant's Core Shelter awarded to him by the World Vision International located at Brgy. Ipil, this city, provided that the City Government of Ormoc retains ownership of the parcel of land where Mr. Jasmin's building is located;

WHEREFORE, premises considered, on motion of Kagawad Mariano Y. Corro, Chairman, Committee on Public Properties, jointly seconded by mga Kagawad Sotero M. Pepito and Benjamin B. Lladoc; be it
