AUTHORIZING THE CITY ACCOUNTANT TO CHARGE RESOLUTION AGAINST PROVISION FOR PRIOR YEAR'S OBLIGATION, A NONDEFICE ACCOUNT IN THE 1996 ANNUAL BUDGET, PAYMENT OF
THE AGEREGATE SUM OF P23,397.33 FOR COMMUNICATION
SERVICES INCURRED BY THE CITY GOVERNMENT WITH ORTELCO, THIS CITY, FOR THE PERIOD AUGUST TO DECEMBER, 1995.

PRESENTED for consideration is a letter dated 28 August 1996 of the DIC-City Treasurer Jesus F. Capahi requesting payment of communication incurred by the City Government with ORTELCO in the aggregate of \$23,397.33 covering the period from August to December 1995;

WHEREAS, this august Body finds out the aforecited request-claim to be in order, being supported with statement of account, official receipts and other supporting papers;

NOW, THEREFORE, on motion of Kagawad Alfredo F. Capahi, Chairman, Committee on Finance, jointly seconded by mga Kagawad Benjamin B. Lladoc and Sotero M. Pepito; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to approve the foregoing request-claim for payment, and do, as this body hereby does, authorize the City Accountant to charge against provision for prior year's obligations, a non-office account in the 1996 Annual Budget, payment of the aggregate sum of \$23,397.33 for communication services incurred by the City Government with ORTELCO, this city, for the period August to December, 1995;
