RESOLUTION NO. 96-185

A RESOLUTION APPROVING ORDINANCE NO. 96-001 S. 1996 OF THE BARANGAY COUNCIL OF BRGY. DISTRICT 16, THIS CITY, ENTITLED, "AN ORDINANCE PROHIBITING RESIDENTS OF THIS BARANGAY FROM ITS INDESCRIMINATE THROWING OF GARBAGE, AND/OR UNSANITARY DISPOSAL OF ANY WASTE MATERIALS, AND PROVIDING PENALTIES THEREOF."

WHEREAS, this Sanggunian is in receipt of Ordinance No. 96-001 s. 1996 from the Barangay Council of Brgy. District 16, this city, entitled, "An Ordinance prohibiting residents of this barangay from its indiscriminate throwing of garbage, and/or unsanitary disposal of any waste materials, and providing penalties thereof", for review as mandated by Section 57 of the Local Government Code of 1991;

WHEREAS, this august Body, through the representation of the Honorable Chairman, Committee on Laws & Ordinances, has observed that said Ordinance has conformed to the pertinent provisions of the Local Government Code, hence, reasonable and within the province of the Sangguniang Barangay of Brgy. District 16 to legislate;
