APPROVING ORDINANCE NO. 96-001 OF BARANGAY OF DISTRICT 24, THIS A RESOLUTION SANGGUNIANG BARANGAY OF DISTRICT 24,
ENTITLED: AN ORDINANCE PROHIBITING RESIDENTS OF THIS BARANGAY FROM ITS INDESCRIMINATE THROWING OF GARBAGE, OND/OR UNSANITARY DISPOSAL OF ANY WASTE MATERIALS, AND PROVIDING PENALTIES THEREOF".

WAEREAS, this Sanggunian is in receipt of Ordinance No. 96-001 of the Sangguniang Barangay of District 24, this city, entitled, "AN ORDI-NANCE PROHIBITING RESIDENTS OF THIS BARANGAY FROM ITS INDESCRIMINATE THRONING OF GARBAGE, AND/OR UNSANITARY DISPOSAL OF ANY WASTE MATERIALS, AND PROVIDING PENALTIES THEREOF";
