RESOLUTION NO. 96-186

A RESOLUTION APPROVING ORDINANCE NO. 96-001 OF THE
SANGGUNIANG BARANGAY OF DISTRICT 24, THIS CITY
ENTITLED: "AN ORDINANCE PROHIBITING RESIDENTS OF THIS
BARANGAY FROM ITS INDESCRIMINATE THROWING OF GARBAGE,
AND/OR UNSANITARY DISPOSAL OF ANY WASTE MATERIALS, AND
PROVIDING PENALTIES THEREOF".

WHEREAS, this Sanggunian is in receipt of Ordinance No. 96-001 of
the Sangguniang Barangay of District 24, this city, entitled, "AN ORDI-
NANCE PROHIBITING RESIDENTS OF THIS BARANGAY FROM ITS INDESCRIMINATE
THROWING OF GARBAGE, AND/OR UNSANITARY DISPOSAL OF ANY WASTE MATERIALS,
AND PROVIDING PENALTIES THEREOF";

AND/OR UNSANITARY DISPOSAL OF ANY WASTE MATERIALS, AND PROVIDING PENAL-
TIES THEREOF";
