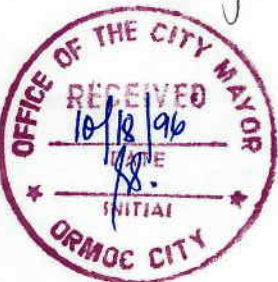

RESOLUTION NO. 96-188

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EUFRO-
SINO M. CODILLA, SR., TO SIGN FOR AND IN BEHALF OF THE
CITY GOVERNMENT OF ORMOC, AS DONEE, THE DEED OF DONA-
TION OF FLORENCIO MONTE, CRISANTA MONTE, FLAVIANA
MONTE, EMERITA MONTE, GREGORIO MONTE, ALBERTA MONTE AND
THE HEIRS OF FABIAN MONTE, REPRESENTED BY DELIA MONTE,
AS DONORS, PROVIDED THAT DELIA MONTE SHALL BE REQUIRED
TO SUBMIT HER SPECIAL POWER OF ATTORNEY AS SHE IS
REPRESENTING THE HEIRS OF FABIAN MONTE.

WHEREAS, this august Body is in receipt of a DEED OF DONATION
executed by and between the City Government of Ormoc, represented by the
Honorable City Mayor as Donee and Florencio Monte, Crisanta Monte,
Flaviana Monte, Emerita Monte, Gregorio Monte, Alberta Monte, and the
heirs of Fabian Monte represented by Delia Monte, as Donors, involving
the following parcels of land and the purpose for which it
would be used:

PARCEL 1 - A parcel of land (Lot No. 5236-A-1-E) with
the improvements thereon, located at Brgy. San Isidro,
Ormoc City, to be used as Road-Right-Of-Way with an area of
FIVE HUNDRED NINETY SIX (596) SQ. METERS.

PARCEL 2 - A parcel of land (Lot No. 5236-A-1-B),
located at Brgy. San Isidro, Ormoc City, to be used as
Multi-Purpose Project of the Barangay with an area of THREE
HUNDRED FORTY EIGHT (348) SQ. METERS.

PARCEL 3 - A parcel of land (Lot No. 5236-A-H), located in Brgy. San Isidro, Ormoc City, to be used as Road-Right-Of-Way with an area of FIVE HUNDRED FIFTY EIGHT (558) SQ. METERS.

WHEREAS, said donation is made out of the donor's civic spiritedness and generosity to help the City Government of Ormoc push through with its plans and programs;

NOW, THEREFORE, on motion of Kagawad Mariano Y. Corro, Chairman, Committee on Public Properties, jointly seconded by mga Kagawad Celso P. Adolfo and Benjamin B. Lladoc; be it

RESOLVED, to authorize THE HONORABLE CITY MAYOR EUFROCINO M. CODILLA, SR., TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOG, AS DONEE, THE DEED OF DONATION OF FLORENCIO MONTE, CRISANTA MONTE, FLAVIANA MONTE, EMERITA MONTE, GREGORIO MONTE, ALBERTA MONTE AND THE HEIRS OF FABIAN MONTE, REPRESENTED BY DELIA MONTE, AS DONORS, PROVIDED THAT DELIA MONTE SHALL BE REQUIRED TO SUBMIT HER SPECIAL POWER OF ATTORNEY AS SHE IS REPRESENTING THE HEIRS OF FABIAN MONTE;

ENACTED, October 17, 1996.

RESOLVED, FURTHER, to furnish copies of this resolution each to His Honor, the City Mayor; the City Legal Officer, the City Treasurer, the Registrar, Register of Deeds, the lot donors as aforementioned and others concerned, -all in Ormoc City;
