

RESOLUTION NO. 96-193

A RESOLUTION FAVORABLY ENDORSING THE INTENTION OR PLAN OF
MRS. AMPARO S. KANGLEON AND THE V & G BETTER HOMES
SUBDIVISION, INC. TO ESTABLISH A GSIS FINANCIALLY-AS-
SISTED SOCIALIZED MASS HOUSING PROJECT IN BARANGAY
CATAYUM, ORMOC CITY.

PRESENTED to this august Body for consideration an Undated Letter
from Mrs. Amparo S. Kangleon and the V & G Better Homes Subdivision,
Inc. requesting for a formal endorsement of the former's intention or
plan to establish a GSIS Financially-Assisted Socialized Mass Housing
Project with V & G Better Homes Subdivision, Inc., in Barangay Catayum,
Ormoc City.

WHEREAS, upon review of said request this august Body has found out
that a Municipal/City resolution is required endorsing the said applica-
tion for conversion, if at the time of the application, the land is
within the agricultural zone as required under Administrative Order No.
12 S. 1994 and that the land applied for conversion will have greater
economic value for residential purposes;

WHEREAS, the proposed subdivision project, as planned by the land
owner, is in consonance with the mandate of R.A. 7279 for Socialized
Housing to benefit the less privileged families of the City of Ormoc;

WHEREFORE, premises considered, on motion of Kagawad Manuel T.
Fiel, Chairman, Committee on Zoning and Beautification, jointly seconded
by mga Kagawad Benjamin B. Lladoc and Chiqui B. Labagala ; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to favorably endorse the intention or plan of Mrs. Amparo S. Kangleon and the V & G Better Homes Subdivision Inc. to establish a GSIS Financially-Assisted Socialized Mass Housing Project in Barangay Catayum, Ormoc City;
