RESOLUTION NO. 96-193

RESOLUTION FAVORABLY ENDORSING THE INTENTION OR PLAN OF NRS. WARRO S KANGLEON AND THE V & G BETTER HOMES SUBDIVISION INC. TO ESTABLISH A GSIS FINANCIALLY-ASSISTED SOCIALIZED MASS HOUSING PROJECT IN BARANGAY CATAYUM, DANGE CITY.

PRESENTED to this august Body for consideration an Undated Letter rom Nrs. Amparo S. Kangleon and the V & G Better Homes Subdivision, requesting for a formal endorsement of the former's intention or establish a GSIS Financially-Assisted Socialized Mass Housing Project with V & G Better Homes Subdivision, Inc., in Barangay Catayum, Ormoc City.

WHEREAS, upon review of said request this august Body has found out that a Municipal/City resolution is required endorsing the said application for conversion, if at the time of the application, the land is within the agricultural zone as required under Administrative Order No. 12 S. 1994 and that the land applied for conversion will have greater economic value for residential purposes;
