A RESCLUTION APPROVING ORDINANCE NOS. UL HAD VZ 1996 OF HE BARANGAY COUNCIL OF SAN JUAN, THIS CITY ENTITLYO AN ORDINANCE PROHIBITING RESIDENTS OF THIS BARANGA FROM ITS INDESCRIMINATE THROWING OF GARBAGE, AND/OR UNSANITARY DISPOSAL OF ANY WASTE MATERIALS, AND "AN ORDINANCE IMPOSING PROXIDING PENALTIES THEREOF" AND "AN ORDINANCE IMPOSING CORFEW, TO ALL PERSONS, WITHIN THE JURISDICTION OF THIS BARANGOY, FROM 10:00 0'CLOCK IN THE EVENING TO 4:00 O'CLOCK IN THE MORNING OF THE FOLLOWING DAY, PROVIDING PENALTIES AND EXCEPTIONS THEREOF".

MHEREAS, this august Body is in receipt of Ordinance Nos. 01 and 02, both from the Barangay Council of San Juan, this city, entitled, "AN ORDINANCE PROHIBITING RESIDENTS OF THIS BARANGAY FROM ITS INDESCRIMINATE THROWING OF GARBAGE, AND/OR UNSANITARY DISPOSAL OF ANY WASTE MATERIALS, AND PROVIDING PENALTIES THEREOF" AND "AN ORDINANCE IMPOSING CURFEW, TO ALL PERSONS, WITHIN THE JURISDICTION OF THIS BARANGAY, FROM 10:00 0"-CLOCK IN THE EVENING TO 4:00 O'CLOCK IN THE MORNING OF THE FOLLOWING DAY, PROVIDING PENALTIES AND EXCEPTIONS THEREOF", respectively;
