RESOLUTION NO. 96-196

A RESOLUTION APPROVING ORDINANCE NO. 96-002 OF THE
BARANGAY COUNCIL OF BRGY. LIBERTY, THIS CITY, ENTITLED,
"AN ORDINANCE PROHIBITING ASTRAY ANIMALS SUCH AS
CHICKENS, PIGS, GOATS, CARABAOS, COWS, AND HORSES FROM
ROAMING AROUND THE BARANGAY PLAZA, SCHOOL PREMISES,
PUBLIC PLACES, AND/OR OTHER PLACES NOT HIS OWN
PROPERTY, PROVIDING PENALTIES IN VIOLATION THEREOF".

WHEREAS, this Sanggunian is in receipt of Ordinance No. 96-002 from
the Barangay Council of Brgy. Liberty, this city, entitled, "An Ordinance prohibiting astray animals such as chickens, pigs, goats, carabaos, cows, and horses from roaming around the barangay plaza, school premises, public places, and/or other places not his own property, providing penalties in violation thereof", for review action as mandated by Section 57 of the Local Government Code of 1991;

WHEREAS, this august Body, through the representation of the Honorable Chairman, Committee on Laws & Ordinances, has observed the said Ordinance has conformed to the pertinent provisions of the Local Government Code of 1991, hence, reasonable and within the province of the Sangguniang Barangay of Brgy. Liberty to legislate;

NOW, THEREFORE, on motion of Kagawad Mariano Y. Corro, Chairman, Committee on Laws & Ordinances, jointly seconded by mga Kagawad Claudio P. Larrazabal and Chiqui B. Labagala; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to approve Ordinance No. 96-002 of the Barangay Council of Brgy. Liberty, this city, entitled, "An Ordinance prohibiting astray animals such as chickens, pigs, goats, carabaos, cows, and horses from roaming around the barangay plaza, school premises, public places, and/or other places not his own property, providing penalties in violation thereof";
