RESOLUTION NO. 96-197

A RESOLUTION RETURNING TO THE SANGGUNIANG BARANGAY OF NAUNGAN, ITS ORDINANCE NO. 01 S. 1996, ENTITLED, "AN ORDINANCE APPROVING THE OFFICIALS USE OF DRY SEAL OF BARANGAY NAUNGAN, ORMOC CITY, IN AUTHENTICATION THE CERTIFICATION, AGREEMENTS, AND OTHER LEGAL DOCUMENTS, TRANSACTION ISSUED AS AUTHORIZED BY THE SANGGUNIANG BARANGAY FOR EXECUTION", AND TO THE SANGGUNIANG BARANGAY OF CAMP DOWNES, ITS ORDINANCE NO. 96-03, ENTITLED, "AN ORDINANCE CREATING A CORPORATE SEAL OF BARANGAY CAMP DOWNES PURSUANT TO DILG, ORMOC CITY MEMORANDUM-CIRCULAR (S-1996) DATED AUGUST 21, 1996", FOR THE REASON THAT BOTH ORDINANCES DO NOT CONTAIN A CONCISE DESCRIPTION OF THEIR BARANGAY CORPORATE SEAL, AND MOREOVER, MR. RODOLFO A. TORCENDE OF DILG, INFORMED THE MEMBERS OF THIS AUGUST BODY THAT HE WILL CALL A MEETING OF ALL MGA PUNONG BARANGAY FOR THE PURPOSE OF DISCUSSING WITH THEM THE PROCEDURE IN THE ENACTMENT OF THE ORDINANCE CREATING THE BARANGAY CORPORATE SEAL AS WELL AS THE SUBSTANCE THEREOF.

WHEREAS, submitted to this august Body for review, as mandated by the provisions of the Local Government Code of 1991, are Ordinance No. 01, entitled, "AN ORDINANCE APPROVING THE OFFICIALS USE OF DRY SEAL OF BARANGAY NAUNGAN, ORMOC CITY, IN AUTHENTICATION THE CERTIFICATION, AGREEMENTS, AND OTHER LEGAL DOCUMENTS, TRANSACTION ISSUED AS AUTHORIZED BY THE SANGGUNIANG BARANGAY FOR EXECUTION" of the Sangguniang Barangay of Naungan, and Ordinance No. 96-03, entitled: "AN ORDINANCE CREATING A CORPORATE SEAL OF BARANGAY CAMP DOWNES PURSUANT TO DILG, ORMOC CITY MEMORANDUM-CIRCULAR (S-1996) DATED AUGUST 21, 1996" of the Sangguniang Barangay of Camp Downes;

WHEREAS, the aforementioned Ordinances are found to be defective, for both do not contain a concise description of their corporate barangay seals, and moreover, Mr. Rodolfo A. Torcende of DILG informed the Members of the Sangguniang Panlungsod ng Ormoc during their Pre-Session Caucus on October 21, 1996 that he will call a meeting of all mga Punong Barangays of this City for the purpose of discussing with them the procedure in the enactment of the ordinance creating the barangay corporate seal, as well as the substance thereof;

WHEREFORE, on motion of Kagawad Mariano Y. Corro, Chairman, Committee on Laws & Ordinances, jointly seconded by mga Kagawad Fernando P. Parrilla and Benjamin B. Lladoc; be it

Codilla, Sr.; the mga Sangguniang Barangay of Naungan and Camp Downes, this city, through their respective mga Punong Barangay; Mr. Rodolfo A. Torcende, CLGOO/LGOO VI; the President of the Association of Barangay Council, and other Offices concerned.
