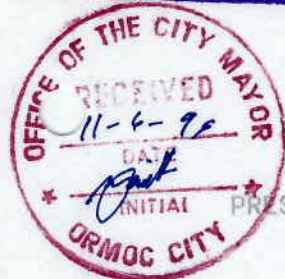

CLEARANCE NO. 012-94 AND DEVELOPMENT PERMIT NO. 012-94 DATED
JUNE 9, 1994, PARTICULARLY LOT NO. 5216-V, PSD-083738-007782-D
(ROAD LOT) OWNED BY QUINTIN MIRO LOCATED AT BARANGAY TAMBULI-
LID, ORMOC CITY, WITH AN AREA OF 1,521 SQ. M. COVERED BY
TRANSFER CERTIFICATE OF TITLE NO. 27537, AND SUBDIVIDED INTO
TWO (2) LOTS.

An application for Alteration of Plan of MIRO'S SUBDIVISION
