RESOLUTION NO. 96-214

A RESOLUTION AUTHORIZING THE HONORABLE MAYOR EUFROCINO M. CODILLA, SR., CITY MAYOR OF ORMOC, TO SIGN THE MEMORANDUM OF AGREEMENT ENTERED INTO BY AND AMONG:

THE CITY GOVERNMENT OF ORMOC REPRESENTED BY ITS CITY MAYOR, HONORABLE EUFROCINO M. CODILLA, SR., WITH PRINCIPAL OFFICE AT ORMOC CITY; AND -

THE BARANGAY INTEGRATED DEVELOPMENT APPROACH FOR NUTRITION IMPROVEMENT (BIDANI) OF THE VISAYAS STATE COLLEGE OF AGRICULTURE (VISCA), WITH PRINCIPAL OFFICE AT BAYBAY, LEYTE, REPRESENTED BY ITS PROJECT DIRECTOR, DR. SAMUEL S. GO, HEREIN REFERRED TO AS VISCA-BIDANI; AND -

THE BARANGAY REPRESENTED IN THIS AGREEMENT BY THE BARANGAY CAPTAIN/CHAIRMAN,

FOR AN INTEGRATED DEVELOPMENT EFFORT TO ACHIEVE NUTRITIONAL IMPROVEMENT, SELF-SUFFICIENCY AND IMPROVED QUALITY OF LIFE AT THE VILLAGE LEVEL IN A SUSTAINED AND ECONOMICAL WAY THROUGH THE INTEGRATION OF EFFORTS BY GOVERNMENT AND NON-GOVERNMENT AGENCIES.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 30 October 1996 from the Honorable City Mayor, the full text of same is hereunder cited as follows:

RESOLVED, AS IT IS HEREBY RESOLVED, to authorize the Honorable Mayor Eufrocino M. Codilla, Sr., City Mayor of Ormoc, to sign a Memorandum of Agreement entered into by and among:

The CITY GOVERNMENT OF ORMOC represented by its City Mayor, Honorable Eufrocino M. Codilla, Sr., with principal office at Ormoc City; and-

The BARANGAY INTEGRATED DEVELOPMENT APPROACH FOR NUTRITION IMPROVEMENT (BIDANI) of the Visayas State College of Agriculture (VISCA), with principal office at Baybay, Leyte, represented by its Project Director, Dr. Samuel S. Go, herein referred to as VISCA-BIDANI; and-

The BARANGAY represented in this agreement by the Barangay Captain/Chairman,

for an integrated development effort to achieve nutritional improvement, self-sufficiency and improved quality of life at the village level in a sustained and economical way through the integration of efforts by government and non-government agencies.
