WHEREAS, ON AUGUST 29, 1996, this Sanggunian adopted Resolution No. 96-141, entitled. CRISTINA C. CON-UI, CITY PLANNING & DEVELOPMENT COORDINATOR, CHAIRPERSON; ATTY. CLETO L. EVANGELISTA, JR., CITY LEGAL OFFICER; ENGR. RUBEN C. PENSERGA, CITY ENGINEER; ATTY. ARTURO SUAREZ, REGISTER OF DEEDS; AND ENGR. DARLITO PAREJA, TAX MAPPER IV, MEMBERS; AND REQUESTING SAID COMMITTEE TO SUBMIT THEIR REPORT AND RECOMMENDATION WITHIN 30 DAYS FROM RECEIPT HEREOF";

WHEREAS, the deadline set for the submission of the report and recommendation of the Committee thus created has long expired, notwithstanding the sending of a tracer to the members thereof, and the submission of the requested report and recommendation cannot be expected in the foreseeable future, as the designated Chairperson has not been reporting to her Office for quite sometime now, and moreover, she has not convened the Committee since its creation;

CON-UI OF THE COMMITTEE CREATED BY THIS SANGGUNIAN UNDER RESOLUTION NO. 96-141, THEREBY AMENDING SAID RESOLUTION ACCORDINGLY, AND APPEALING TO THE SAID COMMITTEE TO SUBMIT SOONEST THEIR REPORT AND RECOMMENDATION WHICH ARE ALREADY LONG OVERDUE;
