EDUARDO P. TAN ACCATED AT BARANGAY SAN PABLO, ORMOC CITY WITH A TOTAL AREA OF 1,000 SUARE METERS COVERED BY TCT NO. 28145 ONTAINING THENTY FOUR (24) SUBDIVISION LOTS EXCLUDING ROAD LOT.
