RESOLUTION NO. 96-218

A RESOLUTION INFORMING WITH REGRETS THE SANGGUNIANG BARANGAY OF CAMP DOWNES, THIS CITY, THAT THEIR RECOMMENDATION TO CHANGE THE NAME OF THEIR BARANGAY TO "BARANGAY I. LARRAZABAL, SR." CANNOT BE ACTED UPON FAVORABLY BY THIS SANGGUNIANG FOR THE REASON THAT THE JUSTIFICATION GIVEN BY THEM FOR THE CHANGE IS CONSIDERED NOT SUFFICIENT.

WHEREAS, this august Body is in receipt of Resolution No. 8, Series of 1996, of the Sangguniang Barangay of Camp Downes, entitled, "A RESOLUTION EARNESTLY RECOMMENDING TO THE CITY MAYOR HON. EUFROCINO M. CODILLA, SR., THRU THE SANGGUNIANG PANLUNGSOD (SIC) NG ORMOC CHANGING THE NAMED (SIC) OF BARANGAY CAMP DOWNES INTO BARANGAY I. LARRAZABAL SR., IN HONOR OF THE LATE CITY MAYOR INAKI A. LARRAZABAL, SR.";

WHEREAS, this Sanggunian is aware of the many good work and performances of the late Inaki A. Larrazabal, Sr., as a public official of Ormoc City, especially as City Mayor;

WHEREAS, the Rules and Regulations Implementing the Local Government Code of 1991, especially Article 23 thereof, sets the guidelines and limitations in changing the name of LGUs with historical, cultural, or ethnic significance, among which are:

- 1) par (a) thereof, the change must be through a unanimous vote of the sanggunian and in consultation with the National Historical Institute (NHI);
- 2) par. (b) (2) A change in name shall be made only for a justifiable reason;

- 3) par. (b) (7) The name of a family in a particular community whose members significantly contributed to the welfare of the Filipino people may be used.

WHEREAS, the aforementioned Resolution anchors its justification as follows: "it is necessary that Barangay Camp Downes be re-named to Barangay Iñaki Larrazabal, Sr., in order to give distinction between the camp and the barangay";

WHEREAS, it is the considered view of this Sanggunian that the foregoing justification advanced by the Sangguniang Barangay of Camp Downes is not sufficient to change the present name of their Barangay which has a historical background;

WHEREFORE, foregoing premises considered, on motion of Kagawad Mariano Y. Corro, Chairman, Committee on Laws and Ordinances, duly seconded by Kagawad Benjamin B. Lladoc; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution INFORMING WITH REGRETS THE SANGGUNIANG BARANGAY OF CAMP DOWNES, THIS CITY, THAT THEIR RECOMMENDATION TO CHANGE THE NAME OF THEIR BARANGAY TO "BARANGAY I. LARRAZABAL, SR." CANNOT BE ACTED UPON FAVORABLY BY THIS SANGGUNIANG FOR THE REASON THAT THE JUSTIFICATION GIVEN BY THEM FOR THE CHANGE IS CONSIDERED NOT SUFFICIENT;

RESOLVED, FURTHER, to furnish copies of this resolution, one each, to the Honorable City Mayor Eufrocino M. Codilla, Sr.; the Sangguniang Barangay of Camp Downes, through the Presiding Officer, the Honorable Punong Barangay; the President of the Association of Barangay Councils, Hon. Fernando P. Parrilla; the Office of Barangay Affairs; Mr. Rodolfo Torcende, NILG, and other Offices concerned.
