RESOLUTION NO. 96-219

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR EULOCINO M. CODILLA, SR. TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, A MEMORANDUM OF AGREEMENT WITH THE LAND BANK OF THE PHILIPPINES, ORMOC BRANCH, ORMOC CITY, RELATIVE TO A MUTUALLY REASONABLE SALARY LOAN FACILITY PROGRAM OF SAID BANK FOR THE REGULAR EMPLOYEES OF THE CITY GOVERNMENT.

WHEREAS, this Sangguniang is in receipt of 1st Indorsement dated 14 October 1996 from the Honorable City Mayor, with an unsigned copy of a MOA or Memorandum of Agreement to be entered into between the Land Bank of the Philippines, Ormoc Branch, and the City Government of Ormoc, and said 1st Indorsement has requested this august Body for passage of a resolution authorizing him to sign the said MOA for and in behalf of the City Government of Ormoc;

WHEREAS, the Department/Division Heads of the City Government of Ormoc, through a letter dated 4 November 1996, have earnestly requested this august Body to act favorably on said MOA for their behalf;

WHEREAS, the 7th Sangguniang Panlungsod ng Ormoc has considered said request of the Honorable City Mayor reasonable, hence, be accorded with due course of action;

WHEREFORE, premises considered, on motion of Kagawad Sotero M. Pepito, jointly seconded by mga Kagawad Chiqui B. Labagala and Fernando P. Parrilla; be it

RESOLVED, to pass a resolution AUTHORIZING THE HONORABLE CITY MAYOR EUFROCINO M. CODILLA, SR. TO SIGN, FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC, A MEMORANDUM OF AGREEMENT WITH THE LAND BANK OF THE PHILIPPINES, ORMOC BRANCH, ORMOC CITY, RELATIVE TO A MUTUALLY REASONABLE SALARY LOAN FACILITY PROGRAM OF SAID BANK FOR THE REGULAR EMPLOYEES OF THE CITY GOVERNMENT;

Codilla, Sr., City Mayor, Ormoc City; Branch Head, Land Bank of the Philippines, Ormoc Branch, Ormoc City; the City Administrator, the City Legal Officer, the City Treasurer and other Offices concerned, in Ormoc City;

CARRIED by MAJORITY VOTES with five (5) Affirmative Votes; four (4) Votes - Against, and two (2) Abstentions registered by mga Kagawad Manuel T. Fiel and Kagawad Deborah Robin B. Conejos.
