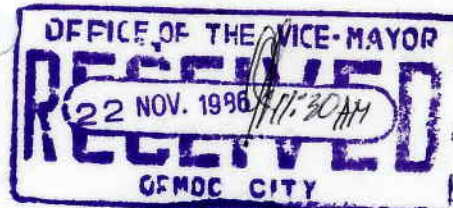
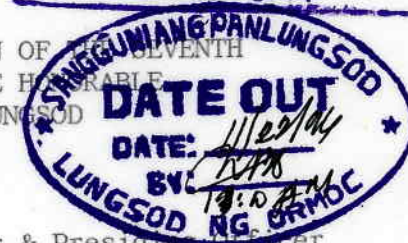

A RESOLUTION CONCURRING AND ADOPTING THE OPINION OF THE CITY LEGAL OFFICER OF ORMOC THAT ORMOC CITY FALLS UNDER THE CLASSIFICATION OF "SPECIAL CITIES" UNDER LOCAL BUDGET CIRCULAR NO. 59 SERIES OF 1996 OF THE DEPARTMENT OF BUDGET AND MANAGEMENT AND CONSEQUENTLY THE CITY OFFICIALS SHALL ENJOY THE RATES OF RATA PROVIDED THEREIN COMMENCING FROM THE DATE OF EFFECTIVITY OF SAID CIRCULAR.

WHEREAS, this Sanggunian is in receipt of a copy of Local Budget Circular No. 59 s. 1996 from the Department of Budget and Management, Regional Office, Tacloban City, the subject of which is "GUIDELINES FOR THE IMPLEMENTATION OF THE REVISED RATES OF REPRESENTATION AND TRANSPORTATION ALLOWANCES AND UNIFORM ALLOWANCE IN THE LOCAL GOVERNMENT UNITS";

WHEREAS, the City Legal Officer in response to the query made by the City Budget Officer as to which rates of RATA the city officials should receive under Local Budget Circular (LBC) No. 59 s. 1996 has opined that, "Ormoc City Officials are entitled to receive the rates of RATA for officials of Special Cities under LBC No. 59, s. 1996"; (Copy of said legal opinion is hereto attached.)

WHEREAS, the SEVENTH SANGGUNIANG PANLUNGSOD ng ORMOC, through the representation of the Honorable Chairman, Committee on Laws and Ordinances, has concurred with the opinion rendered by the City Legal Officer as regards the rates of RATA the City officials are entitled to receive as a consequence thereof;




